I understand that I will be volunteering in a program that serves youth. I understand there will be a criminal records check of me, and I hereby authorize and consent to this criminal records check by the Department and the City of Troy. I understand and agree that my final acceptance as a coach/volunteer will be conditional upon a determination that I have not been arrested or convicted for any crime against children, crime of violence, sexual crime, or any offense that would, in the judgement of the Director of the Troy Recreation Department, make it inappropriate for me to have contact with youth as a coach/volunteer.

I certify that all statements made in this application are true and complete. I authorize the Troy Recreation Department and the City of Troy to investigate all statements made as a part of this application and to secure any necessary information from all prior employers, references, academic institutions, law enforcement agencies, other persons and entities, and public records. I hereby release all such persons, entities, employers, references, institutions, agencies, and the City of Troy and the Department from any and all liability arising from their giving or receiving information about my employment history, academic credentials, qualifications, reputation, driving record, and criminal record.
